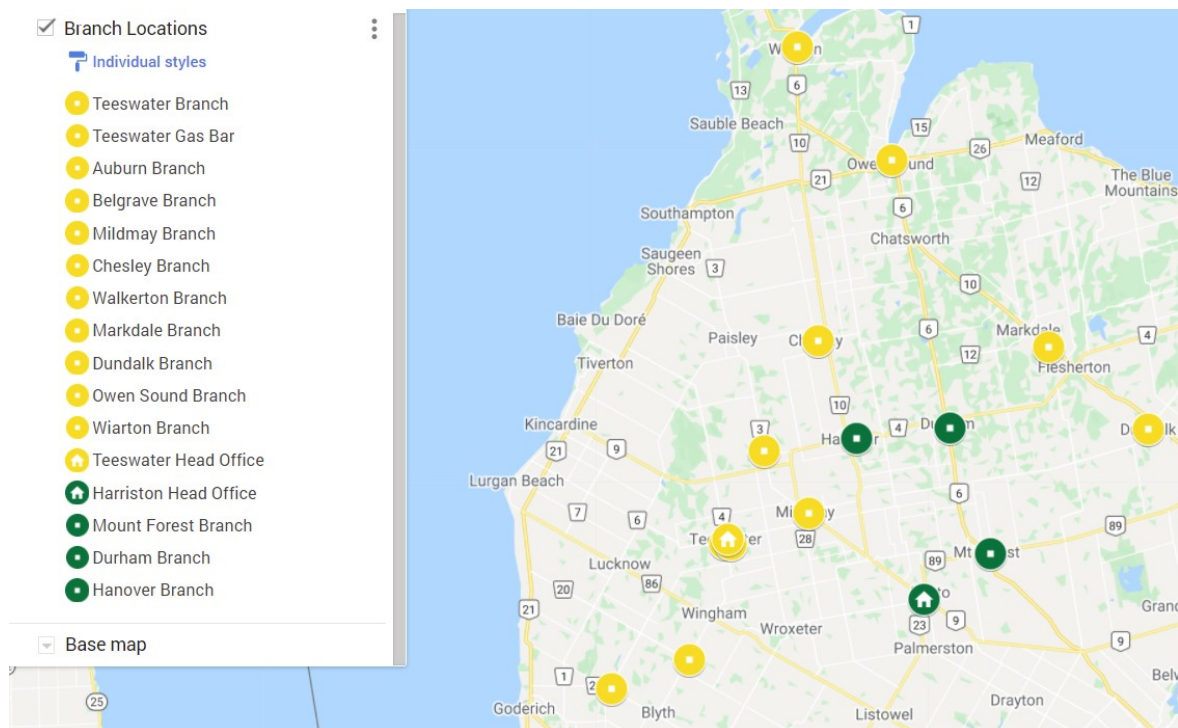



SCHEDULE "A"

Text of Special Resolution Authorizing the Amalgamation

"BE IT RESOLVED THAT:

1. The amalgamation of the Co-operative with Huron Bay Co-operative Inc. pursuant to the terms of the Amalgamation Agreement presented to the Members at a special meeting of Members held on the 11th day of March 2021 (the "Amalgamation Agreement"), is hereby approved and adopted.
2. The proposed by-laws of the Amalgamated Co-operative attached as Schedule "A" to the Amalgamation Agreement are hereby approved and adopted as the By-laws of the Amalgamated Co-operative.
3. The Directors and officers of the Co-operative are hereby authorized to perform or cause all acts and things to be performed, including the execution of such agreements, authorizations and filing of articles as required, to give effect to the amalgamation of the Co-operative and Huron Bay Co-operative Inc., including without limitation, the execution of the Amalgamation Agreement.
4. The Directors of the Co-operative are hereby authorized to make such amendments as the Directors deem necessary to the Amalgamation Agreement."
